2011 2nd Amendment Bills

HB-1079 Repeal restrictions related to the purchase of firearms by out-of-state residents

HB-1129 Define: "Loaded firearm" as "any firearm capable of discharging a projectile, containing cartridges, shells, or projectiles in either the chamber, clip, or magazine;"
(Note: Clip or magazine was not required to be in firearm)

HB-1129TA Properly define: "Loaded firearm" as "any firearm containing an unexpended shell, cartridge, bullet, or projectile in the chamber or cylinder;"

HB-1149 Allow legal residents of the United States to obtain a concealed pistol permit.

HB-1193 Prohibit political subdivisions (counties, townships, municipalities) from restricting possession of firearms.

HB-1193FB Authorize political subdivisions (counties, townships, municipalities) to restrict possession of firearms.

HB-1204** Prohibit businesses and employers from establishing certain policies against the ability of an invitee or employee to store firearms and ammunition in a locked motor vehicle parked on the premises.

2012 2nd Amendment Bills

HB-1015 Constitutional Carry Bill

HB-1132** Prohibit businesses and employers from establishing certain policies against the ability of an invitee or employee to store firearms and ammunition in a locked motor vehicle parked on the premises. *(House Legislators who killed same bill in 2011 HB-1204 (see above) sponsored this bill)*

HB-1248 Modified (HB-1015) Constitutional Carry Bill

HB-1248 (See above) Vote to override Governor Dugaard's veto of the bill.

HB-1258 Prohibit political subdivisions (counties, townships, municipalities) from restricting possession of firearms.
